

**BROKER PARTICIPATION GUIDELINES**

3. The Broker, by signing this document agrees that:
  - A. Broker/Agent must actually show the property to the Buyer/Bidder.
  - B. No oral registration qualifies Broker for commission/referral fee.
  - C. Broker/Agent must attend the auction and assist in the bidding process.
  - D. Broker/Agent agrees he/she will not claim any exceptions to the foregoing procedure unless made in writing and signed by United Country - Redfield Group Auctions, Inc. / c/d/r San Miguel.

The parties acknowledge and agree that the commission/referral fee as described in these guidelines shall be sole commission/referral fee, and payment otherwise payable in connection with the sale of the subject property and that these guidelines supersede any other agreement.

Broker/Agent cannot use these Broker Participation Guidelines in conjunction with any other co-brokerage agreement or agreement to share commission/referral fee made between United Country - Redfield Group Auctions, Inc.– c/d/r San Miguel ("Auction Marketing Company/Auctioneer").
